

Personal information protection notice

SC HIDRAULICA SRL based in Braşov, Str. Muresului, nr. 3, registered with the Trade Registry under no. J08 / 602/1998, having C.U.I. RO10648523, legally represented by Mr. Feher Dezso as Administrator, respects the privacy and security of the processing of the personal data of each person requesting our services.

In accordance with the provisions of Regulation no. 679/2016 for the protection of individuals with regard to the processing of personal data and the free movement of such data, SC Hidraulica SRL is required to manage safely and only for the purposes specified below, the personal data you provide about yourself .

SC HIDRAULICA SRL undertakes to maintain the confidentiality of the personal data provided by you through the requested services.

GENERAL INFORMATION

a) Introduction

The following data protection notice is designed to inform you about the processing of your personal data and your rights in this processing in accordance with European Regulation no. 679/2016 (GDPR) and local legislation in force.

We process personal data for legal and legitimate purposes.

b) The Operator

We, SC HIDRAULICA SRL represent the Operator according to the European Regulation no. 679/2016 (GDPR) and, therefore, we are responsible for processing the data described below. According to the provisions of the Regulation, we have the obligation to manage your personal data in safe conditions and only for the specified purposes.

INFORMATION REGARDING THE PROCESSING

a) The purpose of data collection

We process personal data for legal and legitimate purposes, such as the supply of hydraulic services and systems (high-pressure pneumatic systems and accessories, etc.). This processing is based on Article 6 (1) (a), (b) and (c), as appropriate, from GDPR. We inform you that the recipients of your personal data are employees of the subscribed but, as the case may be, the state institutions, and we do not intend to transfer this data to another company (marketing and advertising company).

What is the basis for the processing of personal data.

The provision of personal data is necessary in order to benefit from the services provided under the best conditions. The basis for which we collect and manage your personal data is primarily to execute a contract or request to become a beneficiary of our services. Also, we process personal data and on the basis of a consent, having a legitimate ground, necessary and indispensable carrying out commercial activities and society's economic situation provided by European Regulation (GDPR).

b) For how long your personal data is collected.

Personal data collected by us will be processed in order to achieve the specific business purpose carrying out commercial activity: during the contract of sale / services, and during the collaboration, based on the given consent and until the request to be erased from the data base. We may also have a legal obligation to keep your data up to date in order to present them to Public Authorities, such as Tax Authorities. Storing and transferring your personal data to public authorities for the purpose of fulfilling a legal obligation is legally based on Article 6 (1) (c) and (e) of the GDPR.

YOUR RIGHTS

As a person, you can send a written notice to: office@hidraulica.ro or at the headquarters in Brasov, Sacele, Avram lancu str., No. 62.

In order to exercise your rights under GDPR, these rights are as follows:

- The right to receive information on data processing and a copy of the processed data (right of access, Art. 15 GDPR)
- The right to request inaccurate data correction or incomplete data (right of access Art. 16 GDPR)

- The right to request the deletion of personal data and, if personal data has been made public, the transmission of information on the removal request to other operators (the right to be deleted Art. 17 GDPR)
- The right to request restriction of data processing (the right to restrict processing Art. 18GDPR)
- The right to receive personally identifiable information about the data subject in a commonly used and mechanized structured format and to request the transmission of this data to another operator (the right of portability Art. 20 GDPR)
- The right to oppose the processing of data with the intention to cease processing (the right to objection Art. 21 GDPR)
- The right to withdraw at any time a given consent to stop the processing of data based on your consent. Withdrawal will not affect the lawfulness of processing on the basis of the consent granted prior to withdrawal (the right to withdraw the consent of Art. 7 of the GDPR)
- The right to file a complaint to a supervisory authority if you consider that data processing is a GDPR violation (the right to file a complaint to a supervisory authority Art. 77 GDPR)

Any information provided by you will be considered and will constitute your express consent that your personal data be used by SC HIDRAULICA SRL for the purposes herein.

For other services (billing / accounting, legal, and email communication), we work with external or internal providers, and some of your personal data can be passed on to them. These providers / users provide sufficient safeguards for data processing to comply with the requirements set out in the Agreement with them.

Users who have access to the personal information database are only those nominated by the company's management and each of them accesses the database with their own username and password.
